1. The Government of **Uganda through the Ministry of Water and Environment** has allocated funds to be used for the **Construction of Lwamata Water Supply System Phase I**
2. The Entity invites sealed bids from eligible bidders for the provision of the above works.
3. Bidding will be conducted in accordance with the Open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from **8:00am -5:00pm**.
5. The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8a and upon payment of a non-refundable fee of **UGX 100,000= (One Hundred Thousand Uganda Shillings)**. The money will be paid to the bank with Bank slips obtained from the Ministry of Water and Environment Accounts section. No cash will be accepted.
6. Bids must be delivered to the address below at 8(c) at or before **11:00am on 15th May, 2019**. All bids must be accompanied by a bid security of **UGX 37,000,000= (Uganda Shillings Thirty Seven Million Uganda Shillings)**. Bid securities must be valid until **11th December, 2019**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives, who choose to attend at the address below at 8(d) at **11:15am on 15th May, 2019**.
